

Rural Municipality of Eldon No. 471

BYLAW No. 128

A Bylaw to provide for entering into an agreement with the member municipalities of the former Maidstone Union Hospital District and Lashburn Hospital District to apportion the Maidstone Union Hospital community generated funds as described in Section 4 of the Maidstone Union Hospital Board - Twin Rivers District Health Board pre-amalgamation agreement.

The Council of the Rural Municipality of Eldon No. 471, in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Eldon No. 471 is hereby authorized to enter into the agreement, as attached hereto and forming part of this Bylaw, and identified as Exhibit A, with the following municipalities:

WHEREAS the Lashburn & District Union Hospital Board has financially contributed to the Maidstone Union Hospital based on an agreement signed April 22, 1980:

WHEREAS the monies paid by the Lashburn & District Union Hospital Board and received by the Maidstone Union Hospital Board were treated in a similar manner as those funds contributed by the sponsoring municipalities of the Maidstone Union Hospital:

AND WHEREAS capital funds were considered to be community generated for pre-amalgamation purposes.

It is agreed that the monies accumulated by the Maidstone Union Hospital Board be proportioned to operating and capital funds utilizing the average percentage rate for the 1992 and 1993 "Requisition for Maidstone Union Hospital Taxes". This amount will be offered back to the sponsoring bodies of the Lashburn & District Union Hospital Board under the same trust conditions as the sponsoring municipalities of the Maidstone Union Hospital Board.

This document becomes part of the pre-amalgamation agreements signed by the sponsoring bodies of the Maidstone Union Hospital Board.

Memorandum of Agreement

Amounts requisitioned from the former Lashburn & District Union Hospital board for the 1993 & 1992 calendar years was:

1993	\$37,574.40
1992	<u>37,729.40</u>
Total	\$75,303.80

The average requisition for the past two years has been \$87,370, of which, \$20,000 was used for capital purposes. Subsequently, $67,370 / 87,370 = 77.1\%$.

Utilizing the $77.1\% \times \$75,303.80 = \$58,059$.

This amount is offered back to the sponsoring municipalities of the Lashburn & District Union Hospital Board in the same proportion as they were requisitioned.
