

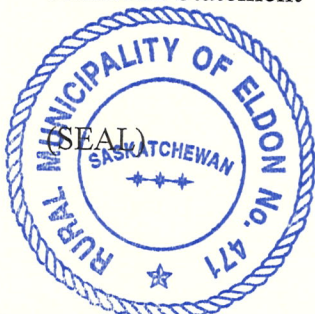


BYLAW No. 5/2016

A BYLAW TO PROVIDE FOR THE REPEAL OF PREVIOUS BYLAWS


The Council of the Rural Municipality of Eldon No. 471, in the Province of Saskatchewan, enacts as follows:


