The Municipality agrees to close the municipal road described as:

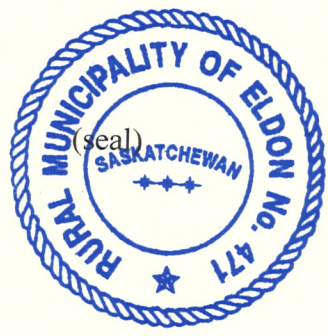
